As we celebrate another remarkable year of impact and progress, I am thrilled to share with you the 2023 edition of the Frederick Health Donor Report.



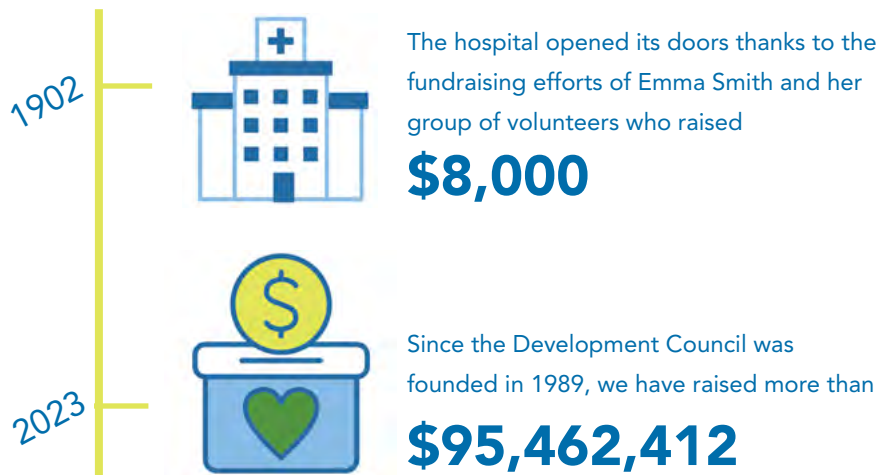

Cancer Patient Assistance Fund

Frederick Health Dental Clinic

The Frederick Health Dental Clinic serves patients who are uninsured, under-insured, or whom have limited means to pay for dental services.



Frederick Health Auxiliary Prenatal Center

The Frederick Health Auxiliary Prenatal Center provides early and continual perinatal care to Frederick County residents who have no access to care due to minimal or no insurance or financial hardship.

Fundraising Campaign Milestones



As we closely monitor our hospital's areas of need as well as the needs of our community, fundraising campaigns are planned to help raise charitable support. Here are three of our most recent fundraising campaigns you may remember.

The *Second Century* and *New Century of Caring Campaigns* (FY1997 - FY2008) raised a combined total of **\$35,361,505** and enabled us to make several necessary construction updates to the hospital.

The *Transforming Healthcare Campaign* (FY2009 - FY2012) raised a total of **\$12,930,735** and funded two critical expansions: the building of a permanent home for the Interventional Cardiology Program, and the creation of a comprehensive Women's Center.

The *Time is Now Campaign* (FY2013 - FY2018) raised a total of **\$23,425,637** and enabled us to open the James M Stockman Cancer Institute - a single convenient location for the compassionate and multidisciplinary care of patients with cancer.

ReEnvisioning Critical Care Campaign Update

We've entered the final year of our 5-year *ReEnvisioning Critical Care Campaign* to renovate and expand the hospital's critical care service areas. We have made significant progress toward our fundraising goal of \$14.75 million, having raised a total of \$11.9 million to date.

Construction Phases



PHASE ONE

The first phase of the project was completed in July 2022 and included renovations of the Adult Emergency Department Waiting Room, Rapid Response Area, Triage Area, Pediatric Emergency Department & Waiting Room, and the Pediatric In-Patient Unit.



PHASE TWO

The second phase of the project was completed in August 2022 and included renovations of the Intensive Care Unit and the Intensive Care Unit Lounge.



PHASE THREE

The third phase was completed in September 2022 and included renovations and expansion of the Cardiac Catheterization Labs.



PHASE FOUR

The fourth and final phase is underway and is estimated to be complete in early 2024. This phase includes completion of large-scale renovations of the Emergency Department treatment zones.

Continuing a Legacy of Leadership

Bess and Frank Gladhill have been prominent members of the Frederick Health donor family for more than 30 years. Their generosity has touched countless lives here at Frederick Health—and throughout the state. While Bess and Frank are sadly no longer with us, their daughters are ensuring that their parents' legacy continues to positively impact the wellbeing of our community.

From the start, Bess and Frank were active in the agricultural community and later, the broader community. "Dad's parents owned a number of farms in Frederick and Montgomery County—where he grew up," explains Bess and Frank's daughter, Lori Mark. "His father died when Dad was only 12 so he really did grow up helping with the farm. Mom was from Carroll County. They met in the mid-1940s before Dad was drafted in the Army during WWII, and they married in 1948. They purchased their first farm in 1950."

Over time, Frank served on the Board of Directors of the Maryland and Virginia Milk Producers Association, Frederick County Agricultural Society, chaired the Frederick County Soil Conservation District, was a member of the state and local Farm Bureaus and the New Market Grange, chaired the Maryland Well Drillers Association Licensing Board and Goodwill Industries of Monocacy Valley, and served on the Frederick County Planning Commission for 15 years. While Frank was busy in these capacities, Bess joined the Frederick Memorial Hospital Auxiliary in 1982. She worked at the Information Desk, as well as the Flowers and Mail detail where her job was to deliver the flowers and cards that had been sent to patients. She eventually became chair of the Flowers and Mail Committee. "She loved it," recalls Bess and Frank's daughter, Sue Gladhill. "It made her so happy to see the delight on the patients' faces when she stopped in their rooms. The Auxiliary opened an entirely new social world for her." Bess was with the Auxiliary for more than 23 years and retired in 2005 with more than 3,400 volunteer hours.





“When I think about my parents, I would have to say that leadership relates to every aspect of their lives,” says Bess and Frank’s daughter, Donna Winch. “They were contributors on all levels, and for many different organizations and causes. They were very supportive of the local agriculture industry, yes, but also of the hospital, Frederick Community College, as well as everyday people in need.”

Bess and Frank created several farm related funds through the Community Foundation of Frederick County. They also established a presidential scholarship at the University of Maryland and supported its Health Sciences and Human Services Library. They also supported Frederick County Public Schools as well as Frederick Community College’s combined library, student tutoring, and faculty professional development facility, which is named after them: the Bess and Frank Gladhill Learning Commons. “Mom and Dad were generous with their time and money,” says Donna.

Bess and Frank made their first gift of \$100 to Frederick Health in 1989 and continued to give generously over the years. In 2005, they made a significant contribution for the creation of a Kid Zone in the emergency department. “Mom loved kids and wanted to help reduce the anxiety children felt when they were patients in the hospital,” says Lori. That same year, Bess and Frank were recognized for their extensive community service and commitment to Frederick when they received Frederick Health’s Good Samaritan of the Year award. “Mom and Dad were honored and humbled to receive this special recognition,” says Lori.



Frank passed away in 2015. In 2017, Bess made a substantial contribution to support the hospital’s *Time is Now Campaign* to build the James M Stockman Cancer Institute. She continued to stay engaged with the hospital until her passing in June 2022. “Prior to Mom’s passing, she had mentioned to us girls that she wanted to support the *ReEnvisioning Critical Care Campaign* by helping to fund the construction of a new Bess and Frank Gladhill Kid Zone in the newly renovated pediatric emergency department and inpatient unit,” says Lori. “Sadly, Mom passed before she could personally make this gift. But knowing it was something she wanted to do, we chose to honor her wishes and made a leadership gift from her estate. We know that it means so much to Mom and Dad that they continue to be part of the hospital.”

Bess and Frank’s granddaughter, Sarah Mark Cornwell, sees the impact of her grandparents’ generosity nearly every day. As a Frederick Health employee, Sarah, like her grandparents, is helping Frederick Health fulfill its mission to positively impact every individual in our community. “I love the fact that I am carrying on a family legacy and working in a capacity that has community impact,” says Sarah. “I think that they would be very pleased by that.”

Why We Give

Drs. Oyebola (Bola) & Yewande Oladeinde joined the **Order of the Good Samaritan** in 2022. With careers in the public health field, they understand the importance of giving back to their local community hospital.



“My wife and I both work in the public health field,” says Dr. Oyebola (Bola) Oladeinde. Bola is a pharmacist and program manager enlisted with the U.S. Public Health Service, a division of the U.S. Department of Health and Human Services and one of the eight uniformed services under the leadership of the U.S. Surgeon General. Yewande is a Social and Behavioral Science Administrator and Program Officer in the Division of Clinical and Health Services Research at the National Institute on Minority Health and Health Disparities, one of the Institutes within the National Institutes of Health.

“You need to be the change you want to see in the world.”

“My research focuses on understanding the role culture plays in shaping people’s perceptions of health and illness, and how it influences their choices and behaviors in seeking or not seeking care and treatment,” Yewande says. “My goal in life both personally and professionally is to work towards addressing the inequities in our society that hinder many from living healthy and productive lives, as I continue to advocate for those that are underserved and marginalized.”

Bola and Yewande were both born in Nigeria. The couple met while in college and moved to Frederick in 2013. “We love Frederick but also continue to embrace our cultural heritage through the Association of Nigerians in Frederick, where Yewande currently serves as president,” says Bola. “We wanted to provide a more formal structure for the work we were doing, and to be more than a social organization,” adds Yewande. “We attained 501(c)3 status several years ago. We continue to partner with different local organizations on initiatives that improve the lives of immigrants in Frederick County. I am very passionate about culture and immigrant life. I was one of the champions for the creation of the Immigrant Affairs Commission in Frederick County in 2021, and currently serve as the Chair.”

“Coming from another country we appreciate the higher level of healthcare that is available here, but we’re very aware of the disparities that exist in America – even in our own community,” says Yewande. “This is why we chose to support the *ReEnvisioning Critical Care Campaign*,” adds Bola. “While it’s important to identify vulnerabilities in community healthcare, it’s equally important to charitably support the advancements and improvements that you want to see take place. You need to be the change you want to see in the world.”

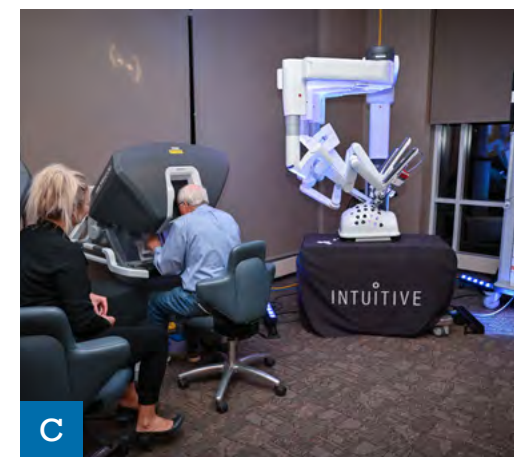

Celebrating the 2023

Good Samaritans of the Year

First presented in 1991, the Good Samaritan of the Year award recognizes individuals whose lives have demonstrated “actions or achievements that have substantially advanced patient care, the economic health of the hospital, or the physical safety of Frederick Health’s patients and personnel, as well as a selfless commitment to improving the quality of life in the entire Frederick community.”

This year’s honors were shared by local physicians Wayne Allgaier, MD, and Peter Kremers, MD. “Dr. Wayne Allgaier and Dr. Pete Kremers have both played important roles in advancing our local healthcare and enhancing the lives of countless Frederick County residents, yet in very different ways,” said Tom Kleinhanzl, President and CEO of Frederick Health.

Following his discharge from the U.S. Navy, Dr. Allgaier and his wife Vicki moved to Brunswick in 1974. Dr. Allgaier established a downtown practice and in addition to seeing patients in his office and at the hospital, he made house calls—something he did for the next 32 years. He is believed to be the last physician in Frederick County to do so. At the time of his retirement in 2008 his practice had grown to include six physicians and several physician assistants—vastly expanding, improving, and ensuring quality healthcare in southwestern Frederick County. Dr. Allgaier retained his professional licensing following his retirement in order to contribute his medical skills in the community. From 2017-2020 he served as a volunteer physician for Mission of Mercy. He also served on the Board of Directors of Hospice of Frederick County. Following his retirement, Dr. Allgaier and Vicki embarked on a series of self-funded, multiple-year mission trips, where he served as a Medical Advisor and assisted young church missionaries across parts of Europe and the U.S. in obtaining needed medical care.

Dr. Allgaier has been equally dedicated to the economic prosperity of his community. He is a two-term elected Brunswick City Council Member, served as Chair of the Board for the Brunswick Economic Development Commission, and Board Chair of the Brunswick Main Street Charter Committee—responsible for establishing the town’s Main Street revitalization program. An advocate for youth, he served as a Scout Leader, and also acted as an allied physician for Brunswick school athletic programs.

Dr. Kremers came to Frederick in 1987. He is credited with updating and expanding the hospital’s radiology department, accomplishing this through the recruitment of excellent new radiologists, as well as an increase in services the department offered to the hospital’s medical staff. He also developed Frederick Health’s Interventional Breast Program, which enabled the hospital to provide same day readings of mammograms as well as same day diagnostic studies if further evaluation was necessary. The program’s protocols were shown to reduce the time between initial tumor discovery and final diagnosis by more than 50%. Dr. Kremers was involved in the design of Frederick Health’s Breast Center at its Crestwood facility, where he researched and helped to select the equipment for the medical unit. He personally developed an FDA-approved device that helps prevent women from getting hematomas that can result during biopsy procedures. Colleagues maintain that his contributions elevated Frederick Health to “state-of-the-art medical status” for individuals seeking radiology services.

His interests and passions have had an equal impact on the Frederick community at large. Carroll Creek Park opened to much fanfare in 2006 following the long-awaited dream of flood control and new development in downtown Frederick. However, for many years, City officials and engineers were at a loss as to how to curtail Carroll Creek Park’s unpleasant algae growth that occurred each summer. Dr. Kremers developed a simple yet elegant plan to solve the algae issue—today known as Color On The Creek, which transformed portions of the park into a spectacular water garden. Dr. Kremers solicited funding from donors and assembled a large team of volunteers to execute the first planting in 2013. Today, Carroll Creek Park’s water garden has become one of downtown Frederick’s biggest seasonal draws, luring tens of thousands of regional and national visitors. In 2017, he launched Sailing Through The Winter Solstice, which calls upon local businesses and non-profits to construct and launch a sea-worthy and creatively-designed boat on Carroll Creek. The event’s fundraising component has also raised nearly \$450,000 for local non-profit organizations.

Why I Give

John (Jack) Brubaker, Jr. has been a member of the **1902 Club** since 1989. For Jack, supporting the hospital is about more than giving back – it’s a way to honor the memory of his late wife, Barbara, and to pay tribute to all that the hospital meant to her.



Originally from Pennsylvania, Jack came to Frederick after enlisting in the U.S. Army following college. “In late 1964 I ended up at Fort Detrick, where I met Jerry Sauder, who was the Assistant Administrator at Frederick Memorial Hospital (FMH),” says Jack. “He introduced me to Barbara Marshall, from Woodsboro, who was a graduate of the hospital’s nursing school. She worked as a Charge Nurse on the Medical Surgical Unit.”

Jack and Barbara were married in October 1965 and lived in Fort Detrick’s post housing. In 1967, their first child was born. Jack went off active duty and taught business education at Linganore High School and later was hired as a junior accountant in the IBM Card Plant in Washington, DC. IBM took them to New Jersey, California, and North Carolina before returning to Maryland in 1987. Their family grew to include three additional children during their time away. They have one 8-year-old grandson.

“Barbara had the Servant’s Heart,” says Jack. “She loved being a nurse and was great at her job. She was adamant about coming back to Frederick. She returned to her work as a RN at FMH. Barbara’s love of the hospital prompted us join the 1902 Club in 1989, something we decided we would always continue. Much of her life was about the hospital.”

Barbara suffered from bronchiectasis and mild cystic fibrosis. Eventually, because of her compromised immune system, she could not deliver patient care; so she worked in other departments until she retired. “Barbara received wonderful care from Dr. Allen Gilson, who kept her as healthy as possible,” says Jack. Barbara passed away in 2015.

“Marrying Barbara was the best thing that ever happened to me,” says Jack. “I’m proud to continue supporting the 1902 Club to honor Barbara’s memory and express my gratitude. We are blessed to have Frederick Health in our community as they continually strive to provide the best care for us and our families.”
